



CONTRIBUTION FACT SHEET FOR OUR MINISTRY PARTNERS (*DONORS*)

Q. How do I get started sending my support to GCPN dba RESTORE HOPE?

A. RESTORE HOPE projects/workers are supported through contributions to RESTORE HOPE. Donations to the general RESTORE HOPE budget help all mission activity. Donors may also give for specific projects or designated funds that RESTORE HOPE has approved and set up. When making a decision to support a project or designated fund through RESTORE HOPE, it is important to obtain the account # to indicate your support preference. Please use only this account name and number on your check or contribution.

Q. Where do I send my checks and how are they to be made out?

A. Checks should be made out to RESTORE HOPE, with 'general budget' or preference an account indicated on the check *note/memo* section. Do not enter the name of a worker on your contribution as donations for specific individuals are not tax-deductible and cannot be accepted as such by RESTORE HOPE in accordance with IRS and ECFA guidelines. Mail your check to RESTORE HOPE, 1506 W. Pioneer Pkwy, #215, Arlington, TX 76013.

Q. What record/receipt do I receive for tax purposes? How often will I receive it?

A. RESTORE HOPE sends out an initial welcome letter to new donors. Thereafter, all donors will receive an annual contribution summary for the prior year by January 31 of the following year. In addition, for any single contribution of \$250 or more, a separate contemporaneous written acknowledgment will be sent for your records. The donor may obtain additional contribution summaries at any time by contacting the RESTORE HOPE accounting office at 817.276.6494.

Q. Can I give via credit card or electronic fund transfer (EFT)?

A. Yes. RESTORE HOPE can accept online contributions. Visit our giving site at <https://restorehopetoday.kindful.com/>. You may also utilize the various project accounts listed to support our workers and projects listed on this DONATE page.

Q. Can I give by online bill-pay through my bank?

A. Yes. Donors can make regular contribution through online bill-pay which is set up by the donor through his/her bank. Donors can set the amount and frequency. Q. Can I give by donating Stocks, Securities, or Company Matching Funds/Grants?
